





4.1 General information for electrical connection




The electrical connection may only be carried out by authorised personnel in a de-energised condition.

For variants with cable gland, the contact description can be found in the wiring compartment. For cable entries, please use the supplied cable glands. The cables must be laid correctly in the wiring compartment of the switch. After wiring, the wiring compartment of the switch must definately be cleaned (e.g. removal of cables residues), considering that foreign bodies can affect the switching behaviour.





5. Set-up and maintenance

5.1 Functional testing

The function of the component must be tested. The following conditions must be previously checked and met:

- 1. Check the integrity of the cable entry and connections
- 2. Check the switch enclosure for damage
- 3. Check the functionality of the switch by actuating the foot switch

5.2 Maintenance

The function (switching) of the foot switch must be tested in regular intervals. Possible soiling accumulated below the foot pedal must be removed.

A regular visual inspection and functional test, including the following steps, is recommended:

- · Check the switch enclosure for damages
- Check the cable entries and the wire connections

Damaged or defective components must be replaced.

6. Disassembly and disposal

6.1 Disassembly

The product must be disassembled in a de-energised condition only.

6.2 Disposal

The product must be disposed of in an appropriate manner in accordance with the national prescriptions and legislations.
